

What a great idea!Incidentally, you're paying a tiny price for this book - but it comes with \$150 worth of couponsyou can use on Wayne Davies' consulting and tax return review services. Since he is a highlyexperienced tax professional - especially when it comes to Internet businesses (and

affiliateprograms) that's a fabulous deal. OK, on to the book review. The Schedule C in your personal tax return is where you report all your business income and expenses. There are many complex issues that people who prepare their own tax returns typically get wrong. Wayne Davies did a remarkable job of making the concepts absolutely simple. Even depreciation, which as a tax professional (Enrolled Agent) and instructor I devote 2 hours to teaching. Waynebrushed aside the complexities and focused on the parts of the law that were simple to use. (He wisely recommended that if you prefer to deal with the more complex part of depreciation, you should take that to your tax professional.) Another thing that blew me away in that chapter is, that there is another area in depreciation that is so complex that tax pros have a special Facebookforum JUST for that specific issue. Wayne simplified that revision in the law so readers never realizehow complicated the rules are. He just makes it clear. I love this book. It's terrific, not just for amateurs, but I will be recommending it to my students, too!

I strongly urge all Schedule C filers to read this book, especially if you prepare your own returns like I used to. The clarity expressed by Wayne Davies is amazing. One can see that this is a book for help, not one to sell a service. Even if you have a tax professional prepare your returns, you will find information in this book that will help assist your self-employment record keeping. I'll bet that the cost will be worth it, probably hundreds or thousands times over. The author's last e-book, Small Business Tax Deductions Revealed, was more comprehensive for business owners in giving an overview of tax requirements and benefits, and is also a highly recommended read. I follow this author simply because I can understand what he's writing without being more confused than before I read it.

As always, Wayne has come thru again. One of the most informative books on the SCH-C available and every CPA & Tax Preparer should make this a must read for their Clients. If you are in the business of a NICHE, you can find what you are looking for in this book. I own every one of Wayne's books and have studied them just as I did my text books in college. I expected a lot more from this book. I am self-employed and have been using Schedule C for a long time. I don't need a book to tell me to list pens and paper under "Office Supplies" (nor does anyone else). But, unfortunately, that is largely what this book offers -- a list of the most obvious business deductions associated with each line of Schedule C. The book suggests that you will learn things you would likely never have thought of yourself but it does not deliver on this promise. I learned nothing new. In fact, there were several things in the book that I am almost certain are misleading at best as written, and outright wrong at worst. (e.g., the section on the meal deduction implies that it can only be used during overnight business trips, which is not true -- it applies to any business-related meal. The section also fails to point out that the standard deduction for overnight lodging cannot be used by self-employed people even though the standard deduction for meals can. It is exactly this kind of information that is very hard to find and which should have been included in a book like this, IMHO.) The reason I am calling this review "bait and switch" is that the book promises 3 free bonuses: a "Top Ten Tax Tips" PDF, an author review of one of your latest taxes, and a 30-minute phone call with the author to ask questions. I went to the website and found that anyone can get all 3 whether they bought the book or not, just by giving an email address (the PDF download includes the coupons for the other two bonuses).

This really helped with my deductions and made doing my taxes easier.
