

This is a GREAT source for PE seismic exam. However, please check the pages, I realized that there are lots of sheets (2 pages each, front and back) are not there. Also a lot of pages are repeated (duplicate) or blank. Great book, bad publisher.Update: I tried to return the item. The seller is not respectful and insisted that all items are QC'ed before shipping, and that the refund is partial. This is very interesting that the seller doesn't apologize for sending me a faulty book.

This workbook is the reason I passed the seismic principles exam. It condenses and makes the pertinent chapters in the asce 7-10 readily accessible and understandable. I skimmed through the workbook chapters but didnt really put it all together until i worked through the 20 practice example problems at the end of the book. There are a few hundred multiple choice problems which I didn't have time to get to other than looking at some questions and solutions on my last day of study. The problems reference equations and tables in the workbook which all come directly from the asce 7-10. U will still need the asce 7-10 for a handful of charts not included in the book.

It is a decent reference for the Civil Seismic Exam for PE exam in California.
