

For proper orientation, it clarifies terms and equips you to detect deceptive arguments that are often made. The book also looks at the external factors persuading the Darwinian worldview. What the reader is left with is a better understanding of the creationist-evolutionist debate in general, as well as the presupposed scientific truth claims of Darwinism that are in fact quite unscientific. Examples include the philosophical assumption of Darwinism that all of reality can be explained by natural explanations (Where $\tilde{A}f\hat{A}\phi\tilde{A}$ \hat{a} $\neg\tilde{A}$ \hat{a} , ϕ s the proof for that?) and faith in an idea that cannot be rigorously tested or falsified. Even in those cases where proof is offered (e.g. The Beak of the Finch) for evolution, Johnson reveals that such is evidence against an argument that no one is making. Obliviously, most of the negative reviewers didn't even read this book. The main focus of this brief book is to give a quick introduction to philosophical, scientific and theological arguments against the Evolution. What most of the negative reviewers are missing is his main point: Evolution as asserted by Dawkins and other fanatics, means the universe and all life in it came by about by chance - it doesn't mean you disagree with darwin's finches or other microevolution. He brings up cases of logical, particularly from microbiologists - objections to evolution that are shot down by 'fanatics' and just as illogical as fundmentalist creationists. For example a 15 year boy in denver objected to NOVA special on evolution being shown in his school. The press portrayed him as a fanatic, but his objection was that the flaws in the show, such as 'the first form of life was a bacteria that fed off of other bacteria' (!). In short, this isn't the either or argument that the press makes it out to be - evolution cannot and has not explained all aspects of life -and for example Richard Dawkin's reductionist theories that we are just walking bits of DNA meant to pass on DNA passes the line from science to fanatical dogma
