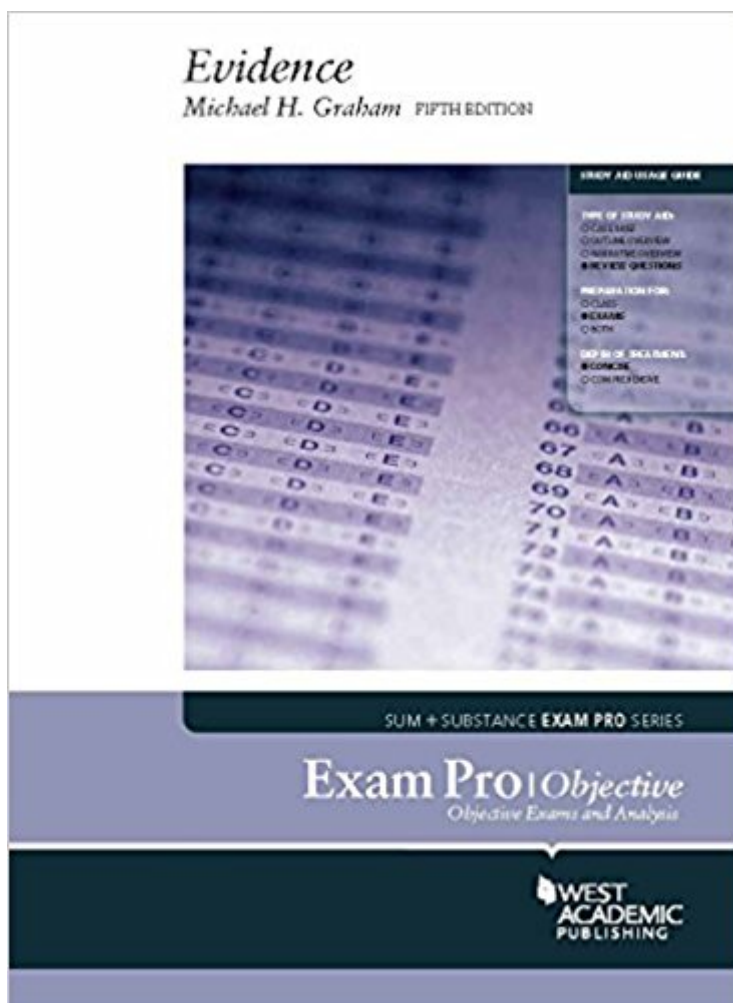

Bottom Line: This book is helpful, but "Questions & Answers: Evidence" by David Leonard, published by LexisNexis is better. As one previous reviewer noted (reviewing an earlier edition), it is written rather badly. The Pros: Subject Matter Review T/F, Hearsay Section with T/F & Multiple Choice, 5 Comprehensive Multiple Choice Tests - good for classes that focus on FRE rather than state law. The Cons: Some of the questions are written so badly it's hard to really tell what is being asked. I don't completely regret purchasing it because it is helpful for review, but there are better books out there.
