This is an easy read with explicit advise for writing a sound report. My favorite part is where it states that an ideal report is 5-7 pages in length (no more than 10 pages). I know people who are writing 20 page reports and our current caseloads are not allowing that kind of time. There may be some suggestions that do not fit with your district's/state's requirements, but overall it is a good resource to have on hand and share with your psychs.

This is a very practical and useful book for those in the field. The examples given are clear and helpful in illustrating how to put the given strategies into practice. Highly recommended!
