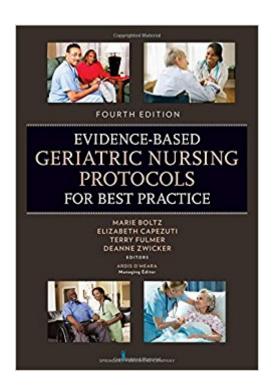

Nursing school text. While this book had a lot of good information, reading it was quite dense. Like many things in nursing, the APA style is used for referencing. In my opinion all the citations in the text make it more cumbersome to read. The material is in the book, and I did well in my geriatrics class, but at times the reading was not exactly a fun experience. I wish authors realized just how unattractive it is to read with all of those citations- it's like you are reading along and bang- now you have to skip 2-3 lines of names you can't pronounce to get back to the meat of the text. Like most students, I don't really care who wrote the article or where the author cited it from, these are not

going to be on the test!! I prefer the superscript format of citations with a reference list at the end so it doesn't interrupt the flow of reading. Otherwise, it is a complete resource for your nursing geriatrics class.

It is an excellent resource for undergraduate CNA's or nursing students.
