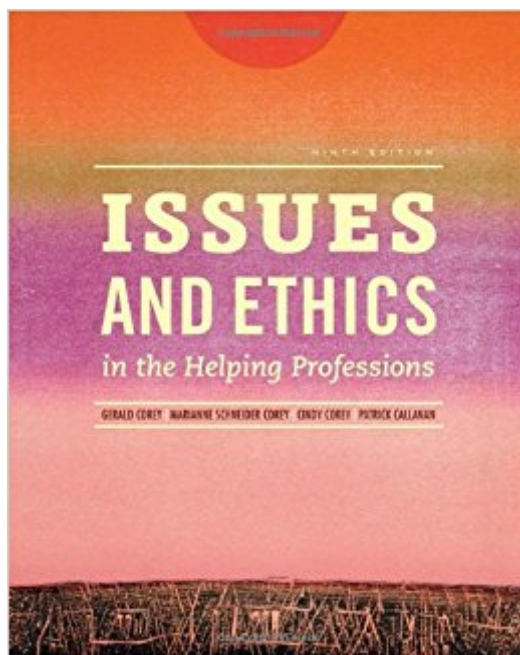

Gerald Corey is Professor Emeritus of Human Services and Counseling at California State University at Fullerton. He received his doctorate in counseling from the University of Southern California. He is a Diplomate in Counseling Psychology, American Board of Professional Psychology; a licensed psychologist; and a National Certified Counselor. He is a Fellow of the American Psychological Association (Division 17, Counseling Psychology; and Division 49, Group Psychotherapy); a Fellow of the American Counseling Association; and a Fellow of the Association for Specialists in Group Work. Both Jerry and Marianne Corey received the Lifetime Achievement Award from the American Mental Health Counselors Association in 2011, and both also received the Eminent Career Award from ASGW in 2001. Dr. Corey was given the Outstanding Professor of the Year Award from California State University at Fullerton in 1991. He regularly teaches both undergraduate and graduate courses in group counseling and ethics in counseling. He is the author or coauthor of 15 textbooks in counseling currently in print, along with more than 60 journal articles and book chapters. In the past 40 years Jerry and Marianne Corey have conducted group counseling training workshops for mental health professionals at many universities in the United States as well as in Canada, Mexico, China, Hong Kong, Korea, Germany, Belgium, Scotland, England, and Ireland. Marianne Schneider Corey, a licensed marriage and family therapist in California, is a National Certified Counselor and a fellow of the Association for Specialists in Group Work. She has been actively involved in providing training and supervision workshops in group process for human-services students and professionals. She also facilitates self-exploration groups for graduate students and continues to conduct training workshops in group counseling with her husband, Dr. Gerald Corey, in various countries. In 2001, the two received the Eminent Career Award for distinguished and major contributions to the field of group work by the Association for Specialists in Group Work. Cindy Corey is a California-licensed psychologist in private practice in San Diego and on the faculty at San Diego State University Community-Based Block Program. She received her doctorate in psychology from the California School of Professional Psychology, Los Angeles. Patrick Callanan is a licensed marriage and family therapist in private practice in Santa Ana, California, and a National Certified Counselor. In his private practice he works with individuals, couples, and families. Patrick is on the part-time faculty of the Human Services Program at California State University at Fullerton, where he regularly teaches the internship course. He also offers his time each year to the university to assist in training and supervising group leaders, and

co-teaches an undergraduate course in ethical and professional issues.

As a Counselor Educator and Counseling Psychologist, I feel that "Issues and Ethics In the Helping Professions" is one of the most nicely organized and well-written texts on counseling ethics ever written. I cannot think of another text I would choose over it to teach ethics to developing counselors. This text serves as an excellent source for the overview of ethical issues in counseling and related fields, as well as a guide to further reading. Corey, Corey, and Callanan expect readers to become involved in learning to deal with ethical and professional issues most directly influenced by the actual practice of counseling. The authors produce numerous useful examples for thought and discussion as well as well designed activities for the classroom setting. Even an instructor selects another text for her or his ethics course, the student should definitely consider purchasing this text as an ethics resource. This edition has also put more emphasis on the learning needs of School Counselors than past editions, although I hope to see it develop in this arena in the 6th edition.

This textbook was well written. While it gives a thorough review of the what I consider a lot of gray area in ethics, it also provides case studies for students to read. The case studies helped students in my class the most by providing examples of how a counselor may be conflicted in a given scenario. It was easy to read and had a lot of useful information.

As a graduate student, I find this book very helpful to understand my responsibilities. This book is well organized. The authors present the material in a way that shows the complexity of the issues and ethics. They give helpful steps that can be taken in the process of caring for one's client and also protecting the therapist. The authors bring in several resources to consider different perspectives. They bring in court cases and how the cases affect the ethical issues. They also supply different ways that counselors may have handled cases and give their opinions about how well these solutions reflected ethical decisions.
